## **DC Poverty Demographics**

Over the past decade, the District has seen job growth, a boom in the real estate market, and improvement of economic conditions by a number of measures. But poverty is still a reality for many of DC's residents. According to estimates using Census Bureau data, one in five District residents lived in poverty, and almost one-fourth of District residents were below 125 percent of poverty, during the time period from 2005 to 2007.

The poverty threshold is set by the federal government and varies by family size. For a family of four, the Federal Poverty Level (FPL) in 2006 equaled roughly \$20,000.

Poverty levels in the District can be broken down by demographics such as age, race/ethnicity, and work status. These distinctions reveal the variations in poverty among different groups of DC residents. (See the table on the following page.) For example:

- Children under the age of 18 are much more likely to live below the poverty level than adults — 29 percent vs. 16 percent.
- Just over eight percent of white District residents lived below poverty, compared with 25 percent of black District residents and 16 percent of Hispanic residents.
- DC has an extremely high rate of poverty among female-headed households 32 percent.
- DC residents with low levels of educational attainment are more likely to be poor than their counterparts with high school or college degrees. Just over five percent of residents with a bachelor's degree or higher lived below the poverty level, compared to 31.5 percent who did not have a high school diploma or equivalent.
